## Guidelines for Authors

Manuscripts are considered for publication in the *Journal* with the understanding that they have not been published or submitted for publication in whole or in part elsewhere. Accepted manuscripts become permanent property of the *Journal* and may not be reprinted elsewhere without permission from the *Journal*.

The guidelines listed below are in accordance with the *Uniform Requirements for Manuscripts Submitted to Biomedical Journals* (October 2004 revision) of the International Committee of Medical Journal Editors (<http://www.icmje.org>). The *Journal* adheres to the principles, policies, and general procedures listed in the *Uniform Requirements* as well as the American Medical Association *Manual of Style*, 9th Edition.

**Copyright Transfer Form.** The copyright transfer form includes the copyright transfer statement, statement of author responsibility, and financial disclosure. The form will be sent to the author(s) of each manuscript when a manuscript is submitted to the *Journal*. A signature is required for each author.

**Authors.** No more than six authors are allowed for one manuscript without permission from the Editor. Authors must limit their affiliations to two institutional affiliations. Resident manuscripts must be coauthored by a member of the residency staff, or a letter of approval must be submitted with the manuscript. Student manuscripts must be coauthored by a faculty member.

**Text.** A three- to six-sentence abstract is needed for all articles except Clinical Pathology and Clinical Correspondence submissions. Subheads should be used at regular intervals. Permission is needed to reprint quoted material; letters of permission should be sent to the Editorial Office at the time of the submission. With few exceptions, all abbreviations must be spelled out.

**Figures.** Digital figures are preferred and should conform to our digital-figure specifications. (See "Technical Guidelines for Figures" elsewhere in this issue.) If initially submitted figures are not publication-quality, such figures should be submitted with any revised version of the manuscript. The author will be contacted if publication-quality figures are still needed at the time a paper is accepted. If digital figures are not available, hard-copy figures should be mailed to the Editorial Office. Traditional photographs should be glossy black-and-white prints, clear, and in sharp focus, preferably measuring 4 × 6 inches; x-rays must be converted to black-and-white prints. Do not clip, staple, or tape prints. The figures must be clearly marked in pencil on the reverse with the figure number, authors' names, and orientation (top). All figures must be numbered and cited sequentially in the text. Figure legends are needed for all figures and should appear at the end of the text. Written per-

mission is needed to reprint figures taken from another source.

**Tables.** Tables should add to the readers' understanding of the text, not repeat what is in the text. Tables must be numbered sequentially and cited in the text; tables are not figures and should be numbered separately. Each table must have a complete title. Written permission is needed to reprint tables taken from another source.

**References.** All references must be numbered and listed in the order in which they appear in the text; after a reference has been cited once, it retains its original number. References must be formatted in JAPMA style:

The style for articles is: author(s), title of article, journal name, volume, page, and year:

The style for books is: author(s), chapter title, title of book, volume number, editor(s), opening page number of chapter cited, publisher, location of publisher, and date of publication:

Jahss MH: "The Subtalar Complex," in *Disorders of the Foot*, Vol 1, ed by MH Jahss, p 727, WB Saunders, Philadelphia, 1982.

If a reference has more than three authors, "et al" is used after the third name. Unpublished references, such as personal communications, should be cited within the text; they should not be included in the reference list. In addition to historical material, current sources should be cited. Authors are also encouraged to use podiatric references, if they are available. Additional references, those not cited in the text, must appear in alphabetical order following the regular reference list.

**Trade Names.** Please verify the spelling of all trade names used. When possible, use generic names instead of trade names. Products mentioned by trade name must be followed by the name and location of the manufacturer in parentheses. If the product is mentioned again, the manufacturer information does not need to be repeated. Trade names should not be used in the title.

**Submission Process.** Manuscripts should be submitted electronically using the online submission system at <http://japma.allentrack.net> (also accessible from the home page of JAPMA Online, <http://www.japmaonline.org>). ## JAPMA ONLINE MANUSCRIPT SUBMISSION AND PEER REVIEW

### Author Submission Instructions

The *Journal* has a Web-based system for manuscript submission and peer review. The system is located at <http://japma.allentrack.net> (also accessible from the home page of JAPMA Online, <http://www.japmaonline.org>). The author submission instructions that appear on the site are reproduced below. For additional help, contact Noelle Boughanmi, Editorial Assistant ([naboughanmi@apma.org](mailto:naboughanmi@apma.org)).

#### Submission Process

The manuscript submission process is broken down into a series of 5 screens that gather detailed information about your manuscript and allow you to upload the pertinent files. The sequence of screens is as follows:

1. A long form asking for author information, title, abstract, and file quantities
2. A screen asking for the actual file locations on your computer (via an open file dialog). After completing this screen, your files will be uploaded to our server.
3. A screen requesting the order in which files should appear in the system-generated merged PDF
4. A completion screen that will provide you with a specific manuscript number for your manuscript
5. An approval screen that will allow you to verify that your manuscript was uploaded and converted correctly. You are allowed to replace and delete files, as well as withdraw the manuscript, on this page.

Before submitting a manuscript, please gather the following information:

- All Authors
  - First Names, Middle Names/Initials, Last Names
  - Institutions
  - Departments
  - Phone and Fax Numbers
  - Street Addresses
  - E-mail Addresses
- Title (you may copy and paste this from your manuscript)
- Abstract (you may copy and paste this from your manuscript)
- Key Words
- Manuscript Files in Word, WordPerfect, or Rich Text Format
- Figures/Images in TIF, EPS, PDF, or JPG formats
- Tables in XLS or DOC format

After the manuscript is submitted, you will be asked to select the order in which you would like the files to be displayed in a merged PDF file that the system will create for you. Next, you will be directed to a page that will allow you to review your converted manuscript. If the conversion is not correct, you can replace or delete your manuscript files as necessary. You may also add additional files at this time. After you have reviewed the converted files, you will need to click on “Approve Converted Files.” This link will have a red arrow next to it. Throughout the system, red arrows reflect pending action items that you should address.

#### Getting Help

If you need additional help, you can click on the help signs spread throughout the system. A help dialog will pop up with context-sensitive help.

#### Manuscript Status

After you approve your manuscript, you are finished with the submission process. You can access the status of your manuscript at any time by:

1. Logging into the system with your password
2. Clicking on the link represented by your manuscript tracking number and abbreviated title
3. Clicking on the “Check Status” link at the bottom of the displayed page

This procedure will display basic tracking information about where your manuscript is in the submission/peer review process.

#### Starting

The manuscript submission process starts by pressing the “Submit Manuscript” link on your “Home” page. Please make sure you have gathered all the required manuscript information listed above **BEFORE** starting the submission process.
